What NW Salicylic Acid 20%w/w Cream is used for?

For removal of warts.

How NW Salicylic Acid 20%w/w Cream works?

The pharmacologic activity of this product is generally attributed to the keratolytic activity of salicylic acid, which is incorporated into a polyacrylic, film-forming virucidal solution designed to cover the wart without the need for a bandage, which results in mechanical removal of epidermal cells infected with wart viruses.

Before using it

Before you start to use it

- -For external use only
- -Consult with your doctor or pharmacist if you have any medical conditions, especially if any of the following apply to you:
 - if you are pregnant, planning to become pregnant, or are breastfeeding
 - if you are taking any prescription or nonprescription medicine, herbal preparation, or dietary supplement

- if you have had a severe allergic reaction (eg, severe rash, hives, difficulty breathing, dizziness) to aspirin or a nonsteroidal anti-inflammatory drug
- if you have liver or kidney problems, a skin infection, skin irritation, eczema, diabetes, or poor blood circulation

Salicylic acid is known to interact with other drugs. Kindly inform your doctor/pharmacist.

How to use NW Salicylic Acid 20%w/w Cream

How to use it

Apply daily and protect surrounding skin (eg with soft paraffin or specially designed plaster), may need to continue up to 3 months.

Kindly contact your doctor/pharmacist for more information.

Side effects

Common side effects may include minor skin irritation, rash, or peeling; or changes in the color of treated skin (usually whitening).

Severe allergic reactions (rash; hives; itching; difficulty breathing; tightness in the chest; swelling of the mouth, face, lips, or tongue); skin redness or irritation.

Stop using salicylic acid topical and call your doctor at once if you have: severe headache, ringing in your ears, a light-headed feeling, like you might pass out; shortness of breath; or severe burning, dryness, or irritation of the skin.

Overdose and Treatment

Symptoms of systemic salicylate poisoning (tinnitus, dizziness and deafness) have been reported after the application of salicylic acid to large areas of skin and for prolonged periods. Salicylism may also occur in the

unlikely event of large quantities being ingested. Kindly contact your doctor/pharmacist for treatment.

This product is contraindicated in children under 2 years of age. Caution must be exercised when older children are treated.

It is dangerous to place any camphor containing product into the nostrils of children. A small amount applied this way may cause immediate collapse.

Storage

Store below 30°C. Keep well closed. Do not allow to freeze.

Keep out of reach of children.

Disposal
