What Axe Brand Heat Oil is used for

For the temporary relief of minor aches and pains of muscles and joints associated with backache, rheumatic pain, lumbago, cramp, sprains and bruises.

How Axe Brand Heat Oil works

Methyl Salicylate, Turpentine Oil and Capsicum Oleoresin when used on skin, are a group of counter-irritants that relieves pain by distracting the brain from receiving pain signals resulting from conditions such as osteoarthritis or injuries such as sprains and strains.

Before you use Axe Brand Heat Oil

When you must not use it

- Known hypersensitivity/ allergy to any of the ingredients, aspirin, other salicylates, or other non-steroidal anti-inflammatory drugs
- Children under 12 years old

Before you start to use it

Please consult your doctor or pharmacist before using if you are:

- Pregnant or breastfeeding

Taking other medicines

For patients taking warfarin (a medicine to prevent blood clots), excessive application onto the skin for muscle or joint pains may increase the chances of bleeding.

How to use Axe Brand Heat Oil

How much to use

Apply a few drops to the affected area and massage gently. For external use only.

When to use it

It can be used any time of the day when relief of symptoms is required. The recommended daily dosage is 3-4 times.

How long to use it

Maximum 5-7 day continuously.

If you forget to use it

Use it when you remember.

If you use too much (overdose)

Overdose of a topically applied medication is unlikely. If you think you or anyone you know has used too much of this product, please contact your doctor or pharmacist for advice.

While you are using it

Things you must do

Use this product for external use only.

Things you must not do

- Do not allow this product to come into contact with your eyes and mouth
- Do not use on damaged skin or on open wounds

Things to be careful of

- Stop use and consult your doctor if:
 - Your condition worsens, persists for more than 7 days or recurs within a few days

- You develop excessive irritation or rashes of the skin

Side effects

Local irritations or allergic reactions (rashes and redness) are usually mild and occur rarely. Please consult your doctor/ pharmacist for further information.
