

## MEDICATED PREMIX: CONTAINS 42.5 g TYLVALOSIN (AS TARTRATE) PER kg

Active substance: 42.5 g (as Tylvalosin tartrate)

**INDICATIONS FOR USE:** 

For the control and treatment of Enzootic Pneumonia, Swine Dysentery and ileitis (Porcine Proliferative Enteropathy).

**NET WEIGHT: 5 kg** 

**DOSAGE AND ADMINISTRATION:** For oral administration in feed only. To obtain therapeutic levels of Tylvalosin, mix **VALOSIN® FG 50** with feed at the following rates:

VALOSIN® FG 50 It is essential to mix well.

**SIGNS AND SYMPTONS OF OVERDOSE AND TREATMENT**: No signs of intolerance have been observed in growing pigs at up to 10 times the recommended dosage.

**WARNINGS AND PRECAUTIONS:** Operators should avoid contact with the skin and eyes and should use dust masks when preparing medicated feed.

**Usage During Pregnancy and lactation:** The safety of the use of **VALOSIN® FG 50** during pregnancy and lactation has not been established. Use in accordance with the risk/benefit assessment by the responsible veterinarian.

**No Known Contra-Indications or Incompatibilities:** Undesirable side effects-adverse reations-none known. **Withdrawal period:** Meat and offal: 2 days.

**Storage**: Do not store above 25°C. Keep the container tightly closed. Store in the original container.

Disposal of Containers: Dispose of in accordance with the laws of the Local Authorities.

Shelf life after incorporation into meal or pelleted feed: 1 month.

**Pharmacodynamics Pharmacokinetics:** Tylvalosin tartrate is a macrolide antibiotic that has antibacterial activity against Gram positive, some Gram negative organisms and mycoplasma.

It acts by inhibiting protein synthesis in the bacterial cell. Tylvalosin tartrate is rapidly absorbed after oral administration of **VALOSIN® FG 50**.

After administration of the recommended dose lung concentrations of 0.06-0.066 pg/ml were found at 2 and 12 hours post-treatment. The parent compound is widely distributed in the tissues with the highest concentrations found in the lungs, bile, intestinal mucosa, spleen, kidney and liver.
