## What WOODS' PEPPERMINT COUGH SYRUP is used for

Provides relief of wet, productive cough.

## How WOODS' PEPPERMINT COUGH SYRUP works

It helps loosen phlegm and thins bronchial secretions to rid bronchial passageways of bothersome mucus and makes cough more productive.

## Before you take WOODS' PEPPERMINT COUGH SYRUP

### - When you must not take it

There are no known contraindications except in cases where individuals show hypersensitivity to ingredients contained in the formulation.

### - Before you start to take it

- Do not take if you are allergic to guaifenesin or any ingredients contained in this drug.
- Tell your pharmacist or doctor if you are pregnant or plan to become pregnant or breastfeeding.

### - Taking other medicines

Guaifenesin has no known serious interactions with other drugs. Therefore, before using this product, tell your doctor or pharmacist of all the products you use.

## How to take WOODS' PEPPERMINT COUGH SYRUP

### - How much to take

Adults and children > 12 years : 10 ml (2 teaspoons)

Children 6 – 12 years : 5 ml (1 teaspoon)

Vary dosage according to age. Repeat every 4 hours or as prescribed by your doctor.

### - When to take it

Productive cough

### - How long to take it

See your doctor if no improvement within 7 days.

### - If you forget to take it

Take the missed dose as soon as you remember it. However, if it is almost time for the next dose, skip the missed dose and continue your regular dosing schedule. Do not take a double dose to make up for a missed one.

### - If you take too much (overdose)

For overdose, treatment is symptomatic and supportive

## While you are taking WOODS' PEPPERMINT COUGH SYRUP

### - Things you must do

Talk to your pharmacist or doctor if your symptoms do not improve.

### - Things you must not do

- Do not give guaifenesin to anyone else, even if they have the same condition as you.

- Do not take guaifenesin to treat any other complaints unless your pharmacist or doctor tells you to.

- Do not take more than the recommended dose unless your doctor tells you to.

### - Things to be careful of

Be careful driving or operating machinery until you know how guaifenesin affects you.

## Side effects

There are no known side effects with normal use.

## Storage and Disposal of WOODS' PEPPERMINT COUGH SYRUP

### - Storage:

Store below 30C. Avoid from direct sunlight. Keep container tightly closed. Keep out of reach of children.

### - Disposal:

Do not take this medicine after the expiry date stamped on the pack
