## What Ketotop<sup>®</sup> is used for

Ketotop<sup>®</sup> is indicated for the treatment of the signs and symptoms of the following.

- Swollen and painful joints
- Stiff shoulders and shoulder pain
- Inflammation of tendons
- Muscular pain
- pain, swelling resulting from trauma

## How Ketotop<sup>®</sup> works

Ketotop<sup>®</sup> is a nonsteroidal anti-inflammatory drug with pain relieving and fever reducing properties with unique and rapid absorption rate through skin.

## Before you use Ketotop<sup>®</sup>

- When you must not use it

Ketotop<sup>®</sup> is contraindicated in patients who have shown hypersensitivity to it, Ketotop<sup>®</sup> should not be given to patients in whom aspirin or other nonsteroidal anti-inflammatory drug induced asthma or other allergic-type reactions. Ketotop<sup>®</sup> should be cautiously administered in patients with bronchial asthma patients.

## How to use Ketotop<sup>®</sup>

### - How much to use

1 plaster of Ketotop<sup>®</sup> should be applied to the affected area twice daily.

## While you are using Ketotop<sup>®</sup>

### - Things you must do

In case of using for treatment of inflammation following skin infection, appropriate antibacterial or antifungal agent should be administered cautiously at the same time, because effects of ketoprofen may mask the usual signs and symptoms of skin infection.

### - Things to be careful of

Treatment of this preparation is not a causal – therapy but a symptomatic therapy. Do not use for eye and mucosa. Do not use for occlusive dressing technique.

## Side effects

Skin: Occasionally redness, rashes, pruritus, dryness and irritation, and rarely swelling may occur. If these symptoms are serious, treatment should be discontinued.

Hypersensitivity reaction: Rarely serious hypersensitivity reaction (hives, shortness of breathing etc.) may occur. If these symptoms appeared, treatment with this preparation should be discontinued.

## Storage and Disposal of Ketotop<sup>®</sup>

### Storage

Store at 30°C. Avoid from direct light.

### Disposal

Medicines should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose

of medicines which are no longer required. These measures will help to protect the environment.

### What it looks like

Ketotop<sup>®</sup> is rectangle shaped plaster having rounded corners, coated with transparent or opalescent adhesive onlight beige coloured lint fabric and mounted on a protective liner.

### Ingredients

Ketotop<sup>®</sup> contains 30mg of ketoprofen for transdermal application.
